



## Technical Regulations Judo

Brasschaat, Belgium  
10 - 14 October 2019

Updated: 29 August 2019

### 1. EVENTS

Judo competitions will comprise the following events:

#### 1.1. Individual Events

Men	Women
-60kg	-48kg
-66kg	-57kg
-73kg	-63kg
-81kg	+63kg

#### 1.2. Competition Team (Men and Women)

**Men: -73kg, -90kg, +90kg**

**Women: -57kg, -63kg, +63kg**

The fighters are engaged in the weight class in which they were weighed (no upgrade of weight during the engagement).

#### 1.3. Kata Team "NAGE NO KATA"

Couples can be composed of either 2 males, 2 females, or a male and a female; mixed (Tori and Uke).

### 2. PARTICIPANTS

#### 2.1. Age Eligibility

**2.1.1.** For competition individual category men, women, competition team men and women: All judo competitors must be at least 15 years old in 2019 (born in 2004 or before).

Competitors aged 15, 16 and 17 in 2004 must provide a medical certificate and the National Association should obtain parental authorisation.

**2.1.2.** For Kata "NAGE NO KATA":

Participants are to be 18 years of age and over (born 2001 or before).

Contestants shall be the holder of black 1st Dan belt or higher.

#### 2.2. Number of Participants

**2.2.1.** For competition individual category Men, Women: Each National Association may enter two (2) competitors per weight class, in each gender, for a maximum of twenty-eight (28) participants for competition category Men, Women;

**2.2.2.** For competition team men and women:

**2.2.2.1.** For competition team men: Each National Association may enter three (3) Holders and three (3) replacements, for a maximum of six (6) participants.

**2.2.2.2.** For competition team women: Each National Association may enter three (3) Holders and three (3) replacements, for a maximum of six (6) participants.

**2.2.3.** For Kata Team: Each National may enter up to a maximum of two (2) couples. The competitors can only participate in a Kata (Nage No Kata). Couple: Tori and Uke. Couples can be composed of either 2 males, 2 females, or a male and a female. A maximum two (2) couples each national.

**2.2.4.** For competition category Men, Women and competition team men / women: Contestants shall be the holder of green belt or higher.

**2.2.5.** For Kata Team: Contestants shall be the holder of black 1st Dan belt or higher.

### **2.3. Non-Starting**

A fine of EURO €30 is levied on each non-starting athlete with the exception of those presenting a doctor's declaration that he/she should not be allowed to start.

## **3. REGISTRATION**

### **3.1. Preliminary Entry Registration**

The preliminary registration with an indication of whether to or not to participate must be submitted to EDSO Technical Director and Representative no later than **10 October 2018**. [Not less than one (1) year before the competition.]

### **3.2. Final Entry Registration**

The final entries entry with an indication of the number of athletes in each event must be submitted to the EDSO Technical Director and Representative no later than **10 April 2019**. [Not less than six (6) months before the competition]. Such submissions will be made via official online registration form followed by the official registration form.

### **3.3. Name Registration**

The name Registration with the names of each athlete indicating event entered must be submitted to the EDSO Technical Director and Representative no later than **10 September 2019**. [Not less than one (1) month before the competitions]. Such submissions will be made via official online registration form followed by the official registration form.

**3.3.1.** No changes or additional entries will be accepted after **10 September 2019**.

## **4. COMPETITION RULES AND REGULATIONS**

### **4.1. Technical Organisation**

EDSO is responsible for the technical organisation of the Judo competitions.

### **4.2. Committees**

#### **4.2.1 Technical Committee:**

The technical committee will be composed of the EDSO Technical Director and members appointed by the Organising Committee:

#### **4.2.2 Protest Committee:**

### **4.3. Competition Rules**

The Judo competitions will be conducted in accordance with the Rules and Regulations of the IJF (version 23 July 2019). In case of disagreement in the interpretation of the Rules and Regulations, the English text shall prevail. Unforeseen incidents not covered by the Rules and Regulations shall be dealt with as follows:

- 4.3.1.** Cases of a general nature will be resolved in accordance with the EDSO General Regulations and Judo Technical Regulations.
- 4.3.2.** Technical questions related to competition rules shall be resolved according to the IJF Rules and Regulations.
- 4.3.3.** Only athletes who comply with the EDSO Regulations are entitled to take part in the EDSO Judo Competitions.
- 4.3.4.** Official rules for arbitration for competition of judo for the deaf and deaf / blind-sighted (double handicap).
  - 4.4.4.1** Official rules for arbitration for competition of judo for the deaf.  
The referee will be placed in the visual field to judo to communicate to them as much as possible.
  - 4.4.4.2** Official rules for arbitration for competition of judo for deaf / blind-sighted (double handicap).  
For judokas deaf blind (deaf / blind), the referee will use the following procedure (see Code of Arbitration IBSA).  
Before starting the fight, we must put them in position Kumi Kata without entering too much normal position and then you can say "Hajime" hitting one time in the back of two athletes.

#### **4.4. Competition Equipment**

- 4.4.1.** All equipment and implements used during competitions will comply with the IJF Rules and Regulations.

#### **4.5. Competition Judogi (Clothing) / Dossards (bibs) Back number**

##### **4.5.1. Competition Judogi**

- 4.5.1.1** Participants must wear competitive uniforms representing their nationality, duly registered and published in accordance with the IJF Rules and Regulations.  
All Judogi for IJF official events must conform to these requirements from 01 April 2015 and must be obligatory with the IJF official Tag (red borders) or else it won't be allowed in competition.
- 4.5.1.2** Participants must observe EDSO Regulations regarding advertisements on their uniforms and clothing worn in the competition area.

##### **4.5.2. Dossards (bibs) Back number**

The bibs must be installed on the back kimonos before the day of the competition. The bibs have to be displayed:

- 1) Label size: 38x39 cm or 39x38 cm
- 2) first name
- 3) family name
- 4) name of the country

If the athlete does not have the backnumber on back kimonos before the day of the competition the NDSF have to pay the penalty fee as listed in the IJF rules.

#### **4.6. Draw**

The draw for all events will be conducted under control of the Technical Committee and in accordance with the IJF Rules and Regulations.

#### **4.7. Competition Plan**

The competition plan will be conducted in accordance with the IJF Rules and Regulations.

#### **4.8. Officials**

#### **4.8.1. Judge/Referee/Umpire**

Allocation of the officials to conduct the events will be made by the Technical Committee. Where ever possible, officials will possess the IJF/EJU international license valid for 2019. However, officials with the highest level of national accreditation may be assigned.

#### **4.8.2. Appointment**

The Organizing Committee will appoint and an appropriate number of officials to conduct each event.

#### **4.9. Unforeseen Incidents**

In the event of unforeseen incidents not covered by the rules and regulations, the Technical Committee will make a determination. In the absence of the Technical Committee, the EDSO Technical Director will make a determination.

#### **4.10. Weigh-in**

The athletes weigh in will be scheduled the day before the competition at Friday 11 October , 7-8 PM at Sportoase Elshout. A weigh in will be operated the morning of the competition, during the Judogi control, prior to the first fight in order to assess the impact of this new decision on the weight of the athletes during the competition. If the collected data require further experimentation, then it will be maintained. A procedure will be implemented when a fighter has a weight over a certain weight tolerance percentage. Within his category (weight to be determined with sport doctors) a medical check may be done.

A separate room for men and women will be available for the unofficial and official weigh-in. There is no limit to the number of times each athlete may check their weight during this time of the unofficial weigh-in. The competitor shall weigh-in wearing only gymnastic underclothing or naked, under the supervision of a weigh-in official; the competitor may be requested to remove his/her underclothing to ensure he/she reaches the minimum weight limit of the weight category in which he/she is entered.

For team competitions the weigh-in is organized one day before the competition. There will be a 2 kg tolerance for athletes who competed in the individual Championships and NO tolerance for athletes who are only inscribed for the team competition.

### **5. VENUES**

#### **5.1. Competition Venue**

The Judo competitions will take place at Sportoase Elshout

##### **5.1.1. Mats**

There will be two competition areas.

Each competition area shall be a minimum of 14 m x 14 m and shall be covered by tatamis or similarly acceptable material, in recommended color which has been approved by the IJF.

The competition area shall be divided into two zones: the contest area and the security area. The contest area shall always be of 8 m x 8 m as minimum size.

The area outside the contest area shall be called the safety area and shall be at least 3m wide.

An adhesive blue tape and a white tape, approximately 10 cm wide and 50 cm long shall be fixed on the center of the contest area at a distance of 4 m apart, to indicate the positions at which the contestants must start and end the contest. The blue tape shall be to the referee's right and the white to his left.

Where two or more adjoining competition areas are used, a common safety area of a minimum of 3 m is permitted, however 4m will be highly recommended for competitor safety.

A free zone, a minimum of 50 cm must be maintained around the entire competition area.

The contest areas will be 8 x 8 m each (with 3m of security around and 4 m minimum in between when two competition areas are adjacent).

### **5.1.2. Flooring**

The competition surface will be Tatamis, accordance with the IJF Tatamis Rules.

### **5.2. Training Venue**

The training venue is the same as the competition venue.

### **6.3. Technical Meeting**

#### **6.3.1. Date and Location**

The first Technical Meeting will be held at Friday 11 october, 8-9 PM at Sportoase Elshout.

The second Technical Meeting will be held at Sunday 13 october, 4-5 PM at Sportoase Elshout.

#### **6.3.2. Attendance**

Each participating National Federation may be represented by two (2) officials, of whom at least one (1) must be deaf and, if necessary, an interpreter.

## **7. CONTROL AND SANCTIONS**

### **7.1. Hearing Devices**

The use of any hearing devices(s)/amplification or external cochlear implant parts is strictly forbidden from the restricted zone area.

#### **7.1.1. Restricted Zone Area**

The restricted zone area is in effect from the time athletes enter the competition area during the warm-up and competition period.

#### **7.1.2. Violation and Penalty**

When this rule is violated, the match shall immediately be stopped, and the offending athlete will be disqualified from the event. Refer to ICSD [Audiogram Regulations](#), 8: Violations and Penalties.

## **8. PROTESTS**

### **8.1. Procedure for lodging a protest**

All sport related protests will be resolved in accordance to the IJF Rules and Regulations and will be managed by the Judo Protest Committee. Any official protest must be submitted in writing in English on the Official EDSO Protest Form. The form must be given to the EDSO Technical Director with EURO €100 within ten (10) minutes after official posted results.

**8.1.1.** The EDSO Technical Director will decide whether the protest is sporting related eligibility related. The Judo Protest Committee will review all sport related protests, and the EDSO Executive Committee will review all eligibility protests. The deposit of EURO €100 will be returned to the appellant only if the protest is considered valid.

### **8.2. Procedures for reviewing a protest**

The Judo Protest Committee will meet in the Technical Director's office in **(location details)** at a time decided upon by the chairperson of the committee.

- The EDSO Representative will be the chairperson of the committee.
- The Sports Liaison Director (SLO) will be responsible to book the meeting room and interpreters.

- The Sports Liaison Director (SLO) will contact all committee members to inform them of the meeting time and location.
- The EDSO Technical Director will be responsible for liaising with the State Sports Association's Competition Manager.
- The Sports Liaison Director (SLO) will be responsible for informing the hosting Deaf Sport Federation and the EDSO Technical Director will be responsible for informing EDSO Executive Committee about the protest and also the outcome of the protest.
